## **Educational Objectives:**

2. To describe some limitations on how a training institute can address boundary violations.

3. To describe the ways in which the novel boundary violation described in this story heightens your awareness of the unconscious hopes and wishes we have for our patients.

Susan S. Levine is in private practice of psychotherapy, clinical supervision, psychoanalysis, and writing consultation; she is on the faculty of the Psychoanalytic Center of Philadelphia. Levine's short fiction has been published in *Constellations: a Journal of Poetry and Fiction, International Psychotherapy Institute EBooks*, White *Wall Review, The Write Launch, The MacGuffin, Isele Magazine, Smoky Blue Literary and Arts Magazine*, and *JewishFiction.net*. Two of her stories have been selected as finalists in contests, "Ding, Ding!" for the *Pinch* Literary Award in Fiction in 2024 and "The Ring Cycle" for the *Sacramento Literary Review* Story Prize. Levine is also the author of *Useful Servants* (Jason Aronson, 1996) and *Loving Psychoanalysis* (Jason Aronson, 2009)—a finalist for the Gradiva Award for best clinical book—as well as the editor of *Dignity Matters* (Routledge, 2018), to which she contributed an essay on Hitchcock's *Vertigo*. She recently began using literary workshop techniques to teach clinical writing and was awarded the 2024 Teacher of the Year Award at her psychoanalytic institute.
